In the matter of: Cost Data Book (Corrigendum No. III)

The following changes have been made in the Cost Data Book as corrigendum No. III :

1. **In Chapter 1**, 'Statement of objects and reasons', the following new para be inserted
"12. In case of any inconsistency in Cost Data Book and Electricity Supply Code. The Cost Data Book shall prevail".
2. **In chapter 3**, 'Security'- under the note, the following new para will be inserted:
"10. For Security Amount above Rs. Fifty Lakhs (50,00000), the payment of first Rs. Fifty Lakhs has to be made by way of Banker's Cheque, Cheque or Demand Draft & amount exceeding Rs. Fifty Lakhs may be paid by way of a Bank Guarantee if consumer so desires. The Security Amount for contracted load exceeding 10MW, the total security amount may continue to be paid by way of Bank Guarantee."
3. **In chapter 3**, 'System Loading Charges', under the note Sl. No. 4, the existing provision will be replaced as such

Existing	Read as
In case of enhancement of load, SLC will be charged for the difference of load and under the slab the difference of load falls	"In case of enhancement of load, system loading charges shall be calculated for new load & the S.L.C already paid by the consumer shall be deducted & the balance amount shall be charged. In case the system loading charges for new load are lower than what is already paid by consumer, no refund shall be made."

4. **In chapter 5**, 'Line Charges', at Sl. No. 1.0, under the description 'Private Tube Well and Pumping Set', shall be replaced by "Private Tube Well and Pumping Set (Where transformer is to be installed)"
5. **In Annexure 6**, -"Fixed Line Charge Load 5 KW or more upto 24 KW (including PTW Connection 5 HP and above)", the following note shall be inserted in the last:
"Note:
(i) The above charges for PTW Connection for 5 HP and above are applicable when there is no need of installation of new transformer and any type of augmentation. In case of installation of new transformer for PTW Connection, the rates as specified in Chapter 5, Sl. No. 1.0 shall apply.
(ii) For PTW Connections, the supply shall be provided as follows:

Load of PTW or Pumping Set	Type of Supply
7 HP or below	Single Phase / Three Phase
Above 7 HP	Three Phase
