May kindly refer to ARR/tariff Petitions for the first control period FY 2017-18 to FY 2019-20. As indicated in the tariff filings dated 08.08.2017 that TOD structure for industries shall be submitted separately, based on analysis of load curves for the FY 2016-17 and FY 2017-18 (as attached) the proposed TOD structure is as below:

TOD structure for street light shall however remain unchanged as below:

Hours of the Day	Discount/Penalty
18:00 hrs – 06:00 hrs	0%
06:00 hrs – 18:00 hrs	(+) 20%

This change in TOD structure may, however, require reprogramming/installation of software in the TOD meters. Accordingly, if accepted a transition period of 3 month may be provided for implementation of revised TOD structure and till such time existing TOD structure shall remain applicable.

UPPCL/Discom do not wish any separate TOD structure for arc furnace/induction furnace, Rolling/ Re Rolling Mill industrial consumers as provided in Tariff order 2016-17. It is also to submit that above dispensation may be considered as part of our tariff proposal. Further, it is requested that above proposal may be considered as admitted so that licensee may publish above structure as addendum to earlier published tariff proposal for seeking comments of stabeholders.
